Program overview

The purpose of the Body-Worn Camera Policy and Implementation Program to Support Law Enforcement Agencies (BWCPPI) is to fund the purchase of body-worn cameras (BWCs) that are implemented as part of comprehensive BWC programs implemented in publicly funded law enforcement agencies or correctional agencies that perform law enforcement functions.

In addition, the BWCPPI supports the refinement of established BWC programs through demonstration projects to improve digital evidence workflows, increase prosecutorial readiness, or streamline cross-agency data sharing.

Who can apply

More information on each entity type and eligibility can be found on p. 7 of the [BWCPPI Notification of Funding Opportunity \(NOFO\)](#). The following entities are eligible to apply for the BWCPPI, broken down by entity type.

- **Government Entities:** State governments, County governments, City or township governments, Special district governments, Native American Tribal governments (federally recognized only)
- **Educational Entities:** Independent school districts and public/state-controlled institutions of higher education
- **Other:** Other units of local government, publicly funded law enforcement agencies and publicly funded correctional agencies. This also includes consortiums.

Funding available

A total of over \$22 million is anticipated to be awarded to about 40 recipients in the following categories:

- **Category 1** - 30 awards of up to \$2 million.
- **Category 2** - 6 awards of up to \$2 million.
- **Category 3** - 4 awards of up to \$1 million.

Funding categories

Eligible applicants must submit their application under a category. This year, there are only three rather than five categories of allowable projects, including:

- **Category 1: Site-Based Awards to Publicly Funded Law Enforcement Agencies.** This category supports the implementation or expansion of BWC programs in publicly funded state, local, tribal, and territorial law enforcement agencies, including projects led by multi-agency partnerships.
- **Category 2: Site-Based Awards to Publicly Funded Correctional Agencies.** This category supports the implementation or expansion of BWC programs in publicly funded state, local, tribal, and territorial correctional agencies, including deployments within correctional agencies or among officers engaged in community supervision.
- **Category 3: Digital Evidence Management, Sharing, and Integration Demonstration Projects.** This category supports agencies with established BWC programs that are enhancing their capacity to manage, analyze, and share digital evidence from BWCs and other sources to improve prosecutorial efficiency and case outcomes. Awards under this category may only be used for limited purchase or lease of BWC equipment if directly tied to the project's broader integration goals and the lease/purchase cost does not exceed 25% of the total federal award.

An applicant is permitted to submit more than one application, but each application must be under a different funding category and propose a different project. More information on funding categories can be found on p. 9 of the [BWCPPI NOFO](#).

Program objectives and goals

The goals for the BWCPPI program are listed below. More information on programmatic goals and objectives can be found on p. 11 of the [BWCPPI NOFO](#).

- Strengthen the evidentiary value of BWC footage in criminal investigations and prosecutions.
- Improve the operational effectiveness and safety of law enforcement and correctional personnel.
- Advance agency-level capacity to manage and share digital evidence.

Priority consideration will be given to proposals that address the following items, but more information on priority consideration can be found on p. 10 of the [BWCPPI NOFO](#).

- Directly supporting law enforcement operations (including immigration law enforcement operations);
- Combatting violent crime;
- Supporting services to American citizens;
- Protecting American children;
- Supporting American victims of trafficking and sexual assault; and
- State/local law enforcement efforts that are coordinated with federal law enforcement efforts (including immigration law enforcement efforts)

Period of performance

The performance period for this grant, for all categories, is 36 months, starting October 1, 2025.

Cost share

- A 50% in-kind or cash match required for Categories 1 and 2.
- No match is required for Category 3.

An applicant's SF-424 form must be submitted first to [Grants.gov](https://www.grants.gov) by **October 27, 2025, 11:59 p.m.** Applicants are encouraged to submit the form at least 48 hours prior to the deadline.
